There was a very long discussion on the implications of this and comments ranged from leaving Oceania to withdrawing from any Oceania events, in the end it was decided that the two delegates to the Oceania meeting, Alan Parris and Dan O'Sullivan, would have the final say on what happens.

Dan left the meeting due to a powercut in the Waikato. He phoned Wayne who passed the message to the meeting. Alan continued to chair the meeting and completed the minute taking.

Coaching Expenses

AP brought to the meeting the submitted coaching expenses for the year ending 14/2/2015. It appears that these did not get sent to everyone so AP read it out line by line giving the amount and explanation. Since the NZBSA had already committed \$1600 to the coaching but not yet paid it, it meant only an extra \$375 to be approved.

Discussion ensued over the amounts and what they were for and consensus was reached that they were very reasonable and we had value for money.

Moved HB and Seconded WC that "the NZBSA pay the account submitted subject to suitable receipts being received."

Coaching contract

As the 2014 contract is due to expire Gary Gillard submitted a proposal to fund the coaching for 6 months for \$3750 while the Cuesports Coaching Incorporated Society was set up and obtained its own funds to operate thus removing the onus of the NZBSA and the NZCBS in finding sufficient funds for them to operate. They would become an affiliate of the NZBSA and the NZCBS and would operate just like any other association.

Everyone contributed to the debate and the issues were discussed both for and against. AP moved and NG seconded that "the NZBSA take up the offer of funding the coaching for a final last 6 months at \$3750 and wish them all the best in forming their own society".
